Note:- (8) Candidates included in the Probability List are required to produce Non Creamy Layer Certificate in the case of Other Backward Communities, Community Certificate in the case of SC/ST candidates issued by the Revenue authority and Differently abled candidates are required to produce Disability Certificate concerned at the time of OTR Verification.
