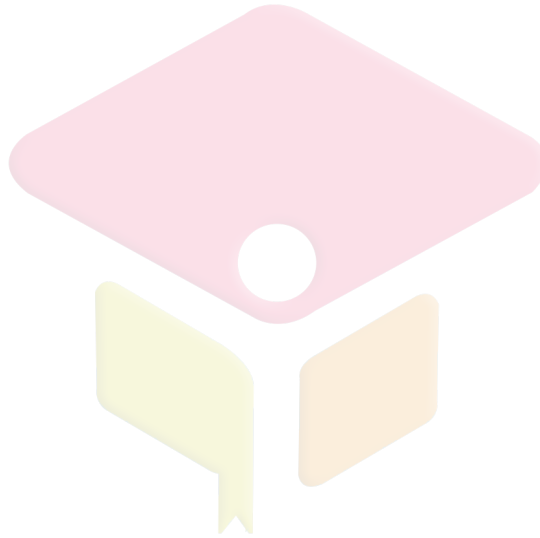

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) SC/ST Candidates included in the Probability List are required to produce community Certificate issued by the Revenue authority at the time of OTR verification. Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SC/ST/DD dated: 26/09/2009 issued by the Revenue authority. EWS Certificate issued by the Revenue authority should be produced by the candidates belonging to Economically Weaker Sections at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on **04-11-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer Scripts of Candidates are invalidated as per Notification No : .ERVII(1)673/2023/EW Dated: 15/02/2023.
